NOTICE IS HEREBY GIVEN that the City of Goleta encourages residents to apply for applications on City Boards, Commissions, and Committees that will have vacancies in 2017.

Pursuant to the Maddy Local Appointive List Act, the following represents the term of appointive offices currently vacant or expiring during the calendar year 2017. Persons interested in serving on a City Board, Commission or Committee should contact the City Clerk's office at (805) 961-7505.

It should be noted that applications for all Boards and Commissions or Committees are accepted throughout the year and will be considered should a vacancy occur.

The Planning Commission shall be residents of the City and shall be qualified electors within the City. (b) Each member shall be a resident of the City for the year immediately preceding the inception of his or her term. (c) No member of the Commission may be an employee or officer of the City. Term of office, (a) Members of the Commission shall be appointed for a four year term which shall expire at the first regular meeting of the first February following the expiration of the current term of office of the City Council member who appointed the Commission member.

The Design Review Board shall be composed of seven (7) members, appointed by the City Council. Of the 7 members, a minimum of four (4) shall be residents of the City. At least two (2) members shall be licensed architects, and at least two (2) members shall be licensed landscape professionals (of which at least one should be a landscape architect). The 3 at-large members must reside within the City. The members shall be skilled in reading and interpreting design drawings and able to judge the effects of a proposed building, structure, landscaping or sign upon the desirability, property value, and development of surrounding areas.

No member of the Public Tree Advisory Commission may be an employee or officer of the City. Term of office. Each appointment of a Public Tree Advisory Commissioner shall be for a term equal to that of the Councilmember who nominated the Commissioner and shall expire when that council seat is vacated or on the next election day for that nominating Councilmember, whichever event occurs first.
