SUBJECT: Consideration of Joint Emergency Operations Center (EOC) with County

of Santa Barbara

RECOMMENDATION:

Receive staff report and provide direction to staff as to whether to proceed with discussions with the County of Santa Barbara for the City's participation in a joint EOC with the County.

BACKGROUND:

Earlier this year, the City of Goleta was approached by the County of Santa Barbara Office of Emergency Services, with regard to a proposal for the City to participate in a joint EOC building project. Said project would be built on existing County owned property located off of Cathedral Oaks Road, adjacent to the Fire Department Headquarters Complex as seen in Attachments 1 and 2. City staff comprising the City Manager and the RDA, Neighborhood Services & Public Safety Director attended preliminary meetings to discuss design concepts and fiscal impacts with regard to requested financial participation and other project related discussions. This staff report is intended to provide the City Council with a report of those discussions and to gauge the level of interest the Council may have with regard to the City's participation.

DISCUSSION:

The County has set aside an estimated \$7 million dollars to construct a joint EOC facility on County owned land, outside of Goleta City limits. Preliminary estimates provided to the City reveal that the County would provide a 750 square foot facility within the proposed complex for the City to use in the event of a local emergency. Attachment 3 provides the most recent proposed floor plan. Associated initial costs approach \$750,000 for the proposed space. These costs represent construction to Critical Facility standards which include building design features to withstand earthquakes, floods, and other hazards.

On going costs to support the City's portion of the EOC complex have not been identified and it is unclear how the City's contribution would be reflected in the ownership of this public facility, located outside of City limits.

Design of the facility would accommodate general or multi-purpose uses during the year as well as back-up power, meeting rooms, communications, food, water, and other necessary capabilities to operate as an EOC during local emergencies. In addition to Goleta, the City of Santa Barbara has also been approached for participation in this proposed project and has indicated a strong interest in co-locating their EOC with the County facility. No other cities in the County of Santa Barbara are participating in this project. Attachment 4 outlines the County's Space Requirements Summary.

As we have seen with the recent GAP Fire, it is clear that coordination and communication among the various agencies during emergency incidents are critical components of any effective emergency management program. Having a facility that brings all of the affected agencies under one roof is a positive goal. As a contract City, Goleta currently does not have a fully equipped EOC facility within City Hall, as the City is in leased space. Participation in the County's EOC project could provide Goleta with enhanced emergency management capabilities. Recent experience reveals that Goleta residents desire a local point of contact for communication and interaction with City Hall.

In conclusion, staff supports the concept of a joint EOC project. However, without further clarity as to the initial and on-going costs and the overall consideration of the City's fiscal condition and ability to support a significant cost for a facility that would be of limited use, staff is hesitant to recommend approval for this project to the City Council. Furthermore, some consideration should be given to the fact that the City has been in discussions about owning our own City Hall which could work to serve our own EOC needs.

ALTERNATIVES:

- 1. The City Council could choose not to participate in this project.
- 2. The City Council could choose to participate in this project, directing staff to obtain the necessary information related to fiscal impacts and return to the City Council for formal consideration and budget related actions.

FISCAL IMPACTS:

Preliminary estimates for Goleta's portion of the joint EOC approach \$750,000. This cost does not include on going costs which have not been identified at this time.


