Public Speakers:

Phil Seymour, Attorney representing Fairview Gardens, spoke to the Fairview Gardens appeal of Development Impact fees (written comments on file). Mr. Seymour spoke to the history of the farm worker units before and after the purchase of the property. Mr. Seymour also spoke to the benefits Fairview Gardens provides to the community.

Karen Boris spoke in support of Fairview Gardens and commented that Fairview Gardens is a nonprofit with an educational mission. Ms. Boris requested that the City wave or significantly reduce the development Impact fees.

Adrianne Davis, President of Board of Trustees of Fairview Gardens Farm, echoed comments made by Mr. Seymour and Ms. Boris. Ms. Davis raised concerns over current economic situation faced by Fairview Gardens.
