Ordinance Prohibiting Commercial Cannabis Activities

NOTICE IS HEREBY GIVEN that the Goleta Planning Commission will conduct a public hearing to consider a Resolution recommending to the City Council adoption of amendments to the Coastal and Inland Zoning Ordinance to prohibit commercial cannabis activities throughout the city. The date, time, and location of the public hearing are set forth below.

PROJECT DESCRIPTION: On November 8, 2016, California voters passed Proposition 64 the Control, Regulate, and Tax Adult Use of Marijuana Act (AUMA). The AUMA establishes a comprehensive system to legalize, control, and regulate the cultivation, processing, manufacture, distribution, testing, and sale of nonmedical cannabis, including cannabis products. The Planning Commission will consider an ordinance prohibiting all commercial cannabis activities authorized under the AUMA throughout all zones in the City. The project is exempt from the requirements of California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Section 15061(b)(3) because they do not have the potential to cause a significant effect on the environment. Since these land uses were not allowed in the state prior to the AUMA, these uses do not exist and the ordinance will maintain the status quo. Therefore, there will be no change to the physical environment.

PROJECT LOCATION: The regulations would apply citywide.
