GENERAL PLAN/COASTAL LAND USE PLAN CONFORMITY REVIEW ASSOCIATED WITH THE ACQUISITION OF A 5,043 SQUARE FOOT PORTION OF CALTRANS RIGHT-OF-WAY ADJACENT TO ASSESSOR PARCEL NUMBER 079-090-038 PURSUANT TO SECTION 65402 OF THE GOVERNMENT CODE (CASE NO. 19-066-GC)

NOTICE IS HEREBY GIVEN that the Planning Commission will conduct a public hearing to consider a General Plan conformity determination for the acquisition of 5,043 square feet portion of Caltrans right-of-way adjacent to Assessor Parcel Number 079-090-038 pursuant to Government Code Section 65402.

ENVIRONMENTAL REVIEW FINDINGS: A Notice of Exemption has been prepared pursuant to the requirements of the California Environmental Quality Act (CEQA) (Public Resources Code §§ 21000, et. seq.), the regulations promulgated thereunder (14 Cal. Code of Regulations, §§ 15000, et. seq.), and the City's Environmental Review Guidelines. The City of Goleta is acting as the Lead Agency for this project. Pursuant to Sections 15061(b)(3) and Section 15378(b)(5) of the CEQA Guidelines, the proposed General Plan conformity determination does not constitute a "project" for the purposes of CEQA because the determination will not result in direct or indirect physical changes in the environment and there is no possibility it will have a significant effect on the environment.

PROJECT DESCRIPTION SUMMARY: In addition to the CEQA Exemption, the Commission will review and take action on a General Plan Conformity Determination in accordance with Government Code Section 65402 associated with the City's acquisition of this portion of right-of-way that is currently vacant and located immediately west of Cathedral Oaks Road, north of Calle Real.

PROJECT LOCATION: The Project site is located at the northwest corner of Cathedral Oaks Road and Calle Real, adjacent to Assessor Parcel Number 079-090-038, also known as 7985 Winchester Canyon Road, in the Coastal Zoning area of the City.

CORTESE LIST: The site is not listed on any hazardous waste facilities or disposal sites as enumerated under Section 65962.5 of the California Government Code (the "Cortese list")
