APPLICANT:

Richard Close, Attorney representing the Applicant, spoke to state laws, tract map and the Development Agreement between the City of Goleta and Goleta Mobile Home Park, LP, A California Limited Partnership. Mr. Close requested a change in the Development Agreement under section 4.01.01.E3 and section 4.01.02.D3 by inserting the word "new" between the words "no" and "pass". Mr. Close also provided copies of letters sent to the City dated February 11, 2009, two letters dated February 12, 2009, and February 13, 2009. Mr. Close noted he would also like to incorporate by reference the testimony and deliberations of the Planning Commission.

Susy Forbath, Attorney representing the Applicant, spoke to available financing options and rental protections for the Rancho Mobile Home Park tenants.

Public Speakers:

James Ballantine, Attorney representing tenants of Rancho Mobile Home Park, spoke to the equity transfer and noted that this is not a resident sponsored conversion. Mr. Ballantine spoke to the amendment of Government Code section 66427.5.

John Douglas (letter on file), Elizabeth Mason, Kabir Chalfin, Jim Webster, Lawrence Boehm, Richard Johnson, Ken Tatro, James Richard, Ron Whipple, Phillip Morgan, Olivia Uribe, Debra Barajas, Karen Lovelace (letter on file), Richard Foster and Ann Ostrowsky raised concerns and spoke in opposition of the Rancho Mobile Home Park Condominium Conversion Project.

REBUTTAL:

Richard Close, Attorney representing the Applicant, emphasized that families earning less than \$80,500 would receive better rent control then what currently exists and their will be no new pass-throughs, hardship rent increases and they will be governed by state laws.

Mayor Pro Tempore Onnen reported the City Attorney stated the Development Agreement is only valid if it is agreed to by both the City of Goleta and Goleta Mobile Home Park, LP, A California Limited Partnership.

Tim Giles, City Attorney, noted that there are two options, Council can reopen the public hearing and invite the applicant to approach the podium and ask if they are willing to agree to the terms. The second option is to make the revision to the Development Agreement and introduce as amended

Richard Close, Attorney representing the Applicant, noted the provision requested by Council will not be acceptable to his client. Mr. Close noted the requested change was a clarification but did not believe the motion proposed a fair clarification, it potentially provides for a rent reduction based upon events that may occur over the next five years. Mr. Close provided examples of events that could potentially contribute to rent reduction. Mr. Close spoke to the suggested fire suppression system improvements and noted it is not required.
