Patty Miller, Current Planning Manager provided a PowerPoint presentation overview of the Towbes/ATK Space Systems Project.

APPLICANT:

Mr. Towbes, The Towbes Group, introduced the Towbes/ATK Space Systems project. He also noted it was vital to ATK's contractual obligations that the proposed project moves forward.

Roger Johnson, Facilities Manager for ATK, presented video clips and a PowerPoint presentation which provided an in depth look of the company, employees and products that the company manufactures. He noted that the company currently has 160 employees (high tech engineering and manufacturing professionals) and noted that 70% of those employees live in the south coast, of which half he reported live in the City of Goleta. He also noted timing of the proposed project is critical, ATK needs to have the manufacturing capability by calendar year 2010 but also needs to show its customers now that they have those facilities online within their manufacturing need dates.

Laurel Perez of Susan Eldridge Planning and Permitting Services noted the video clips provided by Mr. Johnson demonstrated the need for the proposed building editions and specifically the clear space requirements in order for ATK to meet contractual obligations for the construction of Solar Arrays. Ms. Perez provided a PowerPoint presentation overview of the proposed Towbes/ATK Space Systems Project. Ms. Perez requested the ordinance language specify that the proposed project is "approximately" 25, 026 sq ft.

Peter Brown, representing the applicant, spoke to the issue of housing impact fees. Mr. Brown requested that the fees reflect ATK particular qualities such as high technology, higher paying jobs, and the technology type produced within this facility. He further reported that with very large structures being developed, there was one employee per thousand square feet, when usually in an industrial setting it is one employee per 250 square feet, thus noting ATK's unusual situation. He spoke to the survey produced by staff, he suggested the housing fee of \$170,000 was excessive. Mr. Brown suggested that this survey did not really work for ATK for the above mentioned rationale. Mr. Brown recommended consideration of a site specific analysis of ATK's impacts in the amount of \$80, 645.

Cindy Moore, Senior Planner provided a PowerPoint presentation on the proposed Mariposa at Ellwood Shores General Plan Amendment Initiation. Ms. Moore read into record correspondence received from Ingeborg E. Cox and Vic Cox on March 3, 2009.

APPLICANT:

Bendy White, spoke on behalf of Oliver Dixon, the applicant for Mariposa at Ellwood Shores. Mr. White stated that Mr. Dixon is a Santa Barbara native and his family is a 50 plus year business owner in the Goleta Valley. He noted that if the project is to be approved the Dixon family would continue to own and manage Mariposa at Ellwood Shores. He provided a project summary and a PowerPoint presentation of the nationwide and locally projected population growth of individuals ages 65 and older. Mr. White requested that Council initiate a change to the General Plan which would remove inclusionary requirements for locally approved licensed residential care facilities.

Gary Vandeman raised concerns regarding the pay scale of the employees and noted the proposed project is a good example of a project that should provide employee housing.

Barbara Massey spoke in opposition of the proposed General Plan amendment.

Mr. White stated he disagreed with land use issues brought up during the public hearing and noted they will be resolve during the project review. He also noted that if the units are dedicated to affordable housing it would render this project infeasible.

Councilmember Connell reported attending tours of MTD, the Santa Barbara Airport, and ATK. She also reported attending the Track 3 EIR Hearing. Councilmember Connell also recognized the Dos Pueblos High School mock trial team for winning the county championship.

Mayor Aceves recognized the Goleta Valley Junior High School student who won the District Spelling Bee. Mayor Aceves also requested a public discussion on the UCSB LRDP at the March 17, 2009 City Council meeting.
