

## NOTICE OF PUBLIC HEARING Goleta City Council

## Goleta General Plan / Coastal Land Use Plan Case No. 09-020-GPA (Track 2.5)

**NOTICE IS HEREBY GIVEN** that the Goleta City Council will conduct a public hearing to consider proposed General Plan Amendments (Case No. 09-020-GPA) referred to as "Track 2.5." At this meeting, members of the public will have an opportunity to comment on the content of the proposed amendments to the General Plan including recommendations regarding the adoption of the CEQA findings and acceptance of the EIR Addendum. The date, time, and location of the public hearing are set forth below.

**PROJECT LOCATION:** The affected area includes all territory located within the boundaries of the City of Goleta, comprising approximately 7.9 square miles or 5,075 acres. The City is situated along the U.S. 101 freeway about 10 miles west of Santa Barbara between the foothills of the Santa Ynez Mountains and the Pacific shoreline. The southerly portion of the City is within the California Coastal Zone.

**PROJECT DESCRIPTION:** The Goleta General Plan / Coastal Land Use Plan contains policies that guide future development in the City of Goleta. The City is considering amendments (Case No. 09-020-GPA referred to as "Track 2.5") to the building intensity standards included in Land Use Tables 2-1, 2-2, 2-3, and 2-4 and corresponding policy amendments for consistency. "Track 2.5" General Plan Amendments require an Addendum to the General Plan / Coastal Land Use Plan Final EIR adopted in October 2006.

**MEETING DATE, TIMES AND LOCATION:** All interested persons are encouraged to attend the public hearing and to present written and/or oral comment on the scope and content of the proposed amendments to the Goleta General Plan / Coastal Land Use Plan.
