#### OPENED PUBLIC HEARING AT 7:28 P.M.

#### APPLICANT:

Mary Reichel, Project Planner for the applicant provided a PowerPoint presentation of the proposed Haskell's Landing Project. Ms. Reichel also responded to a letter received by both the applicant and City Council from Urban Creeks Council. She expressed concerns that items in the letter were misleading, such as;

1) A significant branch of Devereux creek flows through the middle of the open space of Haskell's landing. Ms. Reichel believes this is incorrect; "this was created during previous development". Noting there is little or no flow on sight as evidence from the leaf litter and presence of upland plant and the absence of riparian plants.

2) Furthermore the letter stated that a red legged frog was found on-site. Ms. Reichel noted in 2001 a red legged frog was discovered 250 feet away on Caltrans property and an analysis was done by Dr. Galen B. Rathbun that indicated there is no perennial or seasonal habitat on the property suitable for the red legged frog which was concurred by U.S. Fish and Wildlife Service.

Barbara Massey, George Relles, Bob Wignot (letter on file), Chris Lange, Deane Plaister, Eddie Harris, and Dr. Ingeborg Cox spoke in opposition of the proposed General Plan Amendments.

Cary Penniman raised concerns over coastal access at Haskell's beach. Mr. Penniman requested Council postpone the approval of the proposed General Plan Amendments.

Herb Rubinstein spoke in support of the proposed Haskell's Landing project and suggested green building elements be installed as an included feature, not as an option.

Mr. Vandeman suggested Haskell's landing reduce its density.

Diane Conn raised concerns regarding the Design Review Board recommendations.

Chuck Lande, applicant, reported the project includes affordable by design units. Mr. Lande addressed the issue of the presence of a red legged frog in 2001, noting Dr. Rathbun analyzed the site and reported the red legged frog was "an errant juvenile". Mr. Lande stated he was willing to add two bedroom affordable units in response to Council's request.

Mary Reichel, Project Planner for the applicant requested that Council allow for flexibility based on "science" in relation to the creek setback.
