**SUBJECT:** Affirm Changes to the City's Strategic Plan

#### RECOMMENDATION:

Review and affirm changes made to the City's Strategic Plan at the March 27, 2009 City Council Work Session.

#### **BACKGROUND:**

The purpose of a Strategic Plan is to reflect the goals and values of an organization and provide direction internally and externally on issues and projects of importance to the City Council and the community. A Strategic Plan is a dynamic document that puts into place for the City to focus its resources. It is constantly changing to reflect new priorities, new input, and new information. In order for a Strategic Plan to be effective and relevant, it must be updated on a periodic basis. It is staff's intention that at a minimum of twice a year, Council will review and refine the goals and issues that emerge throughout the year.

In July 2007, the City Council adopted the City's Strategic Plan. Initially, the Plan was comprised of 17 goals and more than 185 objectives. In December 2007, the Council received an update on the Plan, including objectives and tasks that had been completed and others that were "In Progress." At that time, Council added eight additional objectives to the Plan. In November 2008, the Strategic Plan was again updated, reorganized and culled, resulting in a reduction to 13 goals and 146 objectives.

#### DISCUSSION:

As part of the ongoing Strategic Plan review process, the City Council and key staff participated in a Strategic Plan Work Session on March 27, 2009. The purpose was to review the Vision Statement and the Plan as a whole to ensure that it was reflective of the current Council's vision and priorities. This session also provided an opportunity for staff to weigh in on proposed revisions to the Strategic Plan, including the addition by Council and staff of numerous new tasks and objectives.

In terms of the Vision Statement and stated goals, the Council made several small changes which are now identified in the attached edited version of the Plan. Attachment 1 represents the revised Vision Statement with the agreed upon language changes, whereas edits to the 13 goals are noted in Attachment 2 as a part of the entire edited Strategic Plan.

Objectives and tasks that were either completed or deleted by the Council appear in red strikeout. New objectives are identified in green and modifications to current goals, objectives and task are in blue.

#### **Prioritization Exercise**

At the end of the Council's Work Session each Councilmember was given the opportunity to participate in an exercise aimed at establishing certain priorities within the Plan. Each Councilmember was provided twelve (12) red dots and twelve (12) green dots which were to be placed on items they saw as high priorities. The red dots represented items the Council would like to see made a priority for the City moving into the next two-year budget cycle, beginning July 1, 2009. The green dots represented items that when time and money allowed would become a priority. Put another way; red symbolized objectives of high importance that should be addressed sooner than later, whereas green symbolized priorities that should start in the near future.

Attachments 3, 4, and 5 provide a summary of the priorities the Council placed on various objectives. Generally speaking there was consensus on a number of objectives, although a majority of items listed only received one or two dots.

Attachment 3 is formatted by each goal and in the numerical order organized within the Plan; Attachment 4 is organized in descending order of priority by red dots. Attachment 5 is organized in descending order of priority by green dots.

Through this exercise it became apparent that lacking more specific direction from staff, Councilmembers may have placed numerous dots on single objectives or tasks. While in and of itself this is not a problem, Council may wish to review the new priority list and come to the Council meeting with any questions or comments about high priority items that may have received numerous dots but may or may not represent the consensus of the Council. Such discussion will provide individual Councilmembers with the opportunity to speak to their view of why the objective should be a high priority for the City.

Finally, it should be noted that a significant purpose behind the prioritization exercise is the opportunity for staff to become familiar with the Council's anticipated priorities in order to best address those priorities and, where necessary, be sure they are incorporated into our proposed two-year budget. In that regard, staff proposes working with the priority items that received more than 2 red dots and then focusing on items receiving more than 2 green dots. As demonstrated in Attachment 3, there are exactly twelve (12) items which received three or more red dots and there are seven items which received three or more green dots. That said, it should be pointed out that staff works to regularly review and address objectives contained within the Strategic Plan (no matter how many dots an item receives) and to constantly work to make progress on

any/all of the items we feel we can tackle with current resource levels and based on current needs or Council requests. The list, therefore, provides insight into those items of greatest priority at this time, but doesn't represent a finite or exclusive list.

#### **CONCLUSION:**

As revised and updated, the Strategic Plan went from 146 to 91 objectives – 48 are considered "done" and 7 were deleted. After adding new initiatives, the total amount of objectives now stands at 139 – a total increase of 48. Also of note, there are a total of 298 objectives and tasks combined. Some objectives do not have any tasks. Of the 298 objective and tasks, 74 of them are "In Progress;" or looked at another way, just over 40% of the objectives and tasks in the Strategic Plan are currently being worked on by staff.

This discussion item allows the Council the opportunity to review and affirm the revisions made to the Strategic Plan at the March 27, 2009 Work Session. In addition, the Council should review the priority list to affirm or amend the items identified on the list in anticipation of it being utilized by staff in the upcoming two-year budget cycle and with departmental work programs.
