Executive Summary

1. Introduction

This Action Plan outlines the City of Goleta's Community Development Block Grant (CDBG) activities for the 12-month period from July 1, 2024, to June 30, 2025, or HUD Program Year (PY) 2024-2025. As with all CDBG activities, the projects outlined in this Plan must meet one of the United States Department of Housing and Urban Development's (HUD's) three national objectives for the CDBG program. These objectives include:

- Activities which benefit low- and moderate-income persons;
- Activities which aid in the prevention or elimination of slums or blight; and
- Activities designed to meet community development needs having a particular urgency.

The City's PY 2024 Action Plan goals concentrate on addressing the first national objective - activities which will benefit low- to moderate-income people who reside in the City of Goleta (City), since the City must certify that at least 70 percent of its CDBG funds received over a three-year certification period will be designed to benefit low- and moderate-income persons. The City's PY 2024 proposed projects and activities also support the needs and priorities included in the 2020-2024 Consolidated Plan. The Consolidated Plan is a community blueprint for meeting the housing and community development needs of the City of Goleta. The Consolidated Plan provides a description of existing housing and community development needs, long-term strategies to address those needs, and reflects current community input.

On May 7, 2024, the City was notified that the CDBG allocation for PY 2024 is **\$292,918**. This allows for funding allocations of **\$43,937.70** for public services, **\$58,583.60** for administration of the CDBG program, and **\$190,396.70** for capital projects.

If additional funds become available during the program year from unanticipated increases in appropriation, savings from completed projects, or dropped projects, the City will increase the funding of the Capital Improvement Projects outlined in the PY 2024 Annual Action Plan. No substantial amendments will be required for such an action.

2. Summarize the objectives and outcomes identified in the Plan

The City is committed to allocating CDBG funds to serve the needs of low- and moderate-income residents of the City of Goleta. The City of Goleta has identified special-needs individuals as among those who face the greatest challenges and who should receive high priority in the expenditure of federal funds, including at-risk children and youth, low-income families, the homeless and persons at-risk of becoming homeless, persons with disabilities, and the elderly (especially frail elderly). Priorities can be achieved through a combination of 1) decent and affordable housing; 2) investment in public infrastructure in targeted lowerincome and deteriorating neighborhoods, and in facilities that serve lower-income and/or special needs populations; and 3) public services to low- to moderate-income people, including, but not limited to, health care, food and nutrition programs, educational programs, activities and support for seniors, housing assistance, job training, outreach, case management and counseling for the homeless, enrichment programs for youth, and medical programs for low-income people. Capital projects funded in part with CDBG funds are typically located in Old Town Goleta and Census Tract 30.01, where the City's largest percentage of low- to moderate-income (LMI) people reside. In PY 2024, the City will allocate its capital project funding for critical improvements and/or Americans with Disabilities (ADA) access improvements to the Goleta Community Center building located in Census Tract 30.01. These improvements include, but may not be limited to, structural deficiencies and waterproofing, and potentially ADA access improvements for persons with physical disabilities.

3. Evaluation of past performance

This is an evaluation of past performance that helped lead the grantee to choose its goals or projects.

The City is making progress on the priorities addressing the needs identified and described in its 2020-2024 Consolidated Plan. The City has completed the fourth year of Consolidated Plan implementation. PY 2024 represents the final year of the current Consolidated Plan. The City's greatest challenges are retaining and expanding its stock of affordable housing with the continued high cost of housing and the

Annual Action Plan 2024 lack of undeveloped land within the City. In the current program year, the City is pleased to report on the development of a HOMEKEY permanent supportive housing project in Goleta, Census Tract 30.01. Buena Tierra is a former motel converted into 59 studio apartments with support services for the homeless.

The City continues to look for opportunities to facilitate the development of affordable housing. The factors of high housing costs and the lack of undeveloped land have an impact on the fulfillment of the City's overall goal of developing viable communities through the provision of decent housing, a suitable living environment and expanded economic opportunities for principally low- and moderate-income persons. In contrast, the City has continued to make great strides in assisting low- to- moderate-income people through its CDBG public service funding.

4. Summary of Citizen Participation Process and consultation process

Summary from citizen participation section of plan.

On May 7, 2019, the City amended its Citizen Participation Plan (CPP) as part of adopting its 2019-2020 Action Plan. This CPP is in compliance with the requirements of Title 24 of the Code of Federal Regulations (CFR) Part 91.105. Consistent with that CPP, the City has taken the following actions with regard to public notification and public review:

- On December 14, 2023, a Notice of Funding Availability (NOFA) was released announcing that applications were being accepted from non-profit service providers interested in receiving funds through the City of Goleta's Community Development Block Grant (CDBG) program for PY 2024-2025. The NOFA was published in English in the Santa Barbara Independent, in Spanish in *El Latino* (an all-in-Spanish bi-weekly publication aimed at reaching the bilingual or monolingual Spanish-speaking population in the area), posted on the City's website, and emailed to interested non-profit service providers and past applicants. The application period was open from December 15, 2023, through January 26, 2024.
- On January 9, 2024, the City held a grant workshop to provide a platform for participants to learn about the details of the CDBG program. This encompassed a range of topics, including application processes, eligibility criteria, and grant timelines. The workshop, designed to empower local non-profit organizations with essential knowledge about available grants and funding opportunities, proved to be a resounding success, with approximately 40 people in attendance.
- On February 12, 2024, the City's Human Services Standing Committee met and reviewed the 2024-2025 CDBG Program Year Subrecipient funding applications and Capital Project funding request. The committee prepared funding recommendations for City Council consideration at the March 19, 2024, public hearing.
- On March 19, 2024, the City Council conducted a public hearing on needs, goals, and funding
 priorities for the 2024-2025 Community Development Block Grant (CDBG) Program. Public notices
 for the public hearing were published in English in the Santa Barbara Independent on March 7,

2024 and in Spanish in *El Latino* on March 6, 2024. The public notice was also posted on the City's website.

- A 30-day public review period on the Draft 2024-2025 Action Plan was conducted from April 5, 2024, to May 6, 2024. A public notice advertising this public review period was published in English in the Santa Barbara Independent and Spanish in El Latino on April 4, 2024, posted on the City's website, and emailed to interested social service providers on April 5, 2024.
- The City Council considered the Final Action Plan on **June 4, 2024**, which allowed for additional comments from the public.

5. Summary of public comments

The Santa Barbara County Housing and Community Development Department (HCD) is the lead agency responsible for the application to HUD's Continuum of Care (CoC) Homeless Assistance Program. HCD identifies gaps in homeless program funding and applies to HUD for CoC funds annually for new and renewing projects based on local needs and priorities. The City of Goleta is within the Santa Maria/Santa Barbara County CoC. Homeless persons or those at risk of becoming homeless are also served by the Emergency Solutions Grants (ESG) Program.

The ESG Program provides funding to: (1) engage homeless individuals and families living on the street; (2) improve the number and quality of emergency shelters for homeless individuals and families; (3) help operate these shelters; (4) provide essential services to shelter residents, (5) rapidly re-house homeless individuals and families, and (6) prevent families/individuals from becoming homeless.

The City of Goleta also includes funding, both CDBG and City General Fund money for homeless programs on an annual basis as a priority in its Strategic Plan. Among the programs and service providers supported

in PY 2023-2024 and expected to receive some level of City of Goleta CDBG and local funding in PY 2024-2025 are the Rental Housing Mediation Program, reservation of two beds at the Santa Barbara PATH [Homeless] Shelter, People's Self-Help Housing (case management and homelessness prevention), City Net (outreach and housing navigation), Hedges House of Hope (homeless bridge housing), St. Vincent's Institution (homeless shelter for mothers and children), New Beginnings Counseling Center (safe parking program), Showers of Blessing (free shower and laundry services), and Transition House (emergency shelter and transitional housing for homeless families).

As mentioned in the previous section, the City works closely with the Santa Barbara County Departments of Housing & Community Development, Behavioral Wellness, and Public Health, along with local homeless providers, in addressing the needs of people experiencing homelessness and those at risk of homelessness. The City of Goleta has a staff member on the CoC Board, and City staff attends regular CoC Board meetings as well as CoC Committee meetings. Over the past few years, the City of Goleta has been implementing its first-ever Homelessness Strategic Plan and is working with a variety of regional partners to conduct outreach and provide safe parking, emergency housing, housing navigation, and case management. Other partners the City regularly works with to address the needs of people experiencing homelessness include New Beginnings Safe Parking Program, Good Samaritan Shelter, City Net, and People Assisting the Homeless (PATH).

Annually the City conducts a minimum of two public hearings to allow the public an opportunity to provide input for incorporation into the Annual Action Plan as well as the Consolidated Annual Performance Evaluation and Report. All public hearing meetings are advertised in local newspapers of general circulation (in English and Spanish) and on the City's website. Notices in English are published in the weekly free paper, *The Independent*. Public notices are also published in Spanish in *El Latino Central Coast Newspaper*, the only bilingual—Spanish and English—media outlet (print and online) in the area, reaching more than 30,000 readers every other week. The initial public hearing to gather public input on housing and community development needs, goals and priorities, and funding allocations for the 2024-2025 program year occurred on **March 19, 2024**. The public hearing was held in person and virtually through Zoom, to allow maximum participation. Public input at this hearing and direction from the City Council was incorporated into the Action Plan.

A 30-day public comment period for the Draft 2024-2025 Action Plan was conducted from **April 5, 2024**, to **May 6, 2024**, to give the public the opportunity to review the City's stated priorities for its 2024-2025 CDBG program and submit comments. As noted above, this public comment period was advertised in *The Independent*, a local newspaper of general circulation (English), in *El Latino Central Coast Newspaper* (in Spanish), and on the City's website, Facebook, and Twitter accounts. In addition, potential stakeholders and interested parties were also emailed a notice of availability for the opening of the comment period on the Draft Action Plan.

For PY 2024, the City will allocate its capital project funding (estimated at \$179,431) for critical improvements to the Goleta Community Center building located in Census Tract 30.01. These improvements include, but may not be limited to, building foundation and skylight upgrades to address structural deficiencies and waterproofing, and may include ADA improvements if other funding sources are insufficient to cover costs. Census tract 30.01, generally Old Town Goleta, is the area with the City's greatest percentage of low- to moderate-income residents.

Discussion

The City has been very successful in leveraging financial resources and, in addition to CDBG funding, has successfully competed for many other grants from varying sources, including State of California Parks grants. These grants have supported additional improvements at the Goleta Community Center site and other facilities, such as Mathilda Park, which is using CDBG funds from 2020 to provide new playground facilities and update ADA requirements.

Description of the geographic areas of the entitlement (including areas of low-income and minority concentration) where assistance will be directed

The City of Goleta's CDBG funding for capital projects and public improvements has been concentrated in Census Tract 30.01 which includes Goleta's Old Town district. This area contains the City's highest concentration of low- to moderate-income residents and is the primary census tract that exceeds the HUD exception threshold for Goleta. HUD typically defines a low- and moderate-income area as an area (often a Census Tract) where at least 51 percent of the residents are low and moderate income. However, in some communities, there are no or very few areas in which 51 percent of the residents are low and moderate income. For these grantees, the CDBG regulations authorize an exception criterion in order for such grantees to be able to undertake area benefit activities. The City of Goleta is one of the communities where the exception criteria apply. In addition, only individual Block Groups within the City of Goleta meet the HUD-defined criteria. These qualifying Block Groups are located in Goleta's Old Town district and a high-density residential district on the west side of the city. In these block groups, 47% or more of residents are low-mod income.

In PY 2024, the City will be addressing the needs of persons in Census Tract 30.01, which is the area of Old Town Goleta typically served by CDBG capital funds. In addition, any residual funds would support the entire community of people with disabilities who might visit the Goleta Community Center by addressing additional critical improvements and upgrades to the facility.

CDBG funding for Public Services is directed at low- to moderate-income people citywide.

Rationale for the priorities for allocating investments geographically

For capital projects and public infrastructure improvements, CDBG funding has been spent in a predominantly low- to moderate-income residential area for the LMA national objective, or within an economically depressed or blighted area to meet the Elimination of Slum/Blight national objective. HUD defines a low- and moderate-income area as an area (often a Census Tract or Block Group) where at least 51 percent of the residents are of low and moderate income. The City of Goleta is an exception community, which permits the City to include census tracts and block groups below the 51 percent threshold. In the case of the City of Goleta, only individual Block Groups within the City of Goleta meet the HUD-defined criteria. These qualifying Block Groups are located in Goleta's Old Town district (several

block groups within Census Tract 30.01) and a high-density residential district on the west side of the city. In these block groups, 47% or more of residents are low-mod income. These are the areas where City of Goleta funding will be targeted. In addition, the services provided by the social service sub-recipients are located in a variety of critical locations throughout the city in order to reach those most in need.

Discussion

The City is allocating its entire allocation (minus the 20% for Planning and Administration of the CDBG program) to address the needs of low- and moderate-income persons, including persons with disabilities and those experiencing homelessness. The City does not have any Neighborhood Strategy Areas (NSAs).

AP-75 Barriers to affordable housing -91.420, 91.220(j)

Introduction

In the City of Goleta, the largest barrier to the development of affordable housing is the extremely high cost of real estate and development costs. There are also considerable governmental constraints to affordable housing development that include land use policies governed by the Land Use Element of the General Plan and the zoning and development codes, and development fees imposed by the jurisdiction.

Actions it planned to remove or ameliorate the negative effects of public policies that serve as barriers to affordable housing such as land use controls, tax policies affecting land, zoning ordinances, building codes, fees and charges, growth limitations, and policies affecting the return on residential investment

The City's Housing Element is required to provide a detailed assessment of public policy constraints and to develop strategies to alleviate the constraints on development of new housing, and particularly, those that act as barriers to affordable housing. Major governmental constraints to affordable housing development include land use policies governed by the Land Use Element of the General Plan and the zoning and development codes, and development fees imposed by the jurisdiction. For example, stringent standards relating to building height, lot coverage, setbacks, open space requirements, and parking requirements often reduce the number of units that can be achieved on a given site. In addition, lengthy development approval and permit processing procedures can increase the cost of development substantially. In most cases, lengthy development and permit approval process occurs when a conditional use permit and/or design/architectural review are required and if clear standards for review are not established. Development impact fees are also charged to a new development to pay for the necessary local infrastructure to serve the development which increases the cost to develop new housing. The City of Goleta completed a several-year-process of developing a new zoning code that was adopted in February 2020, and in doing so, has carefully examined current development standards, land use policies, and permit processing requirements to remove unnecessary barriers to development of affordable housing. This included an examination of current land use controls to determine where processing efficiencies can be improved. In an effort to encourage and remove development barriers for Accessory Dwelling Units (ADUs), the City does not charge any development impact fees for these units. In addition, the City's recently updated Housing Element and related zoning code amendments effected changes to facilitate the development of housing. These changes included increasing height limits, calculating maximum allowable density based

Annual Action Plan 2024 some commercial zones to 20 units per acre.

Discussion

The City supports affordable housing project construction through its local Affordable Housing Trust Fund as well as Santa Barbara County HOME Consortium funding. The City continues to support a regional approach to addressing affordable housing needs but does encourage the use of HOME funds in and/or around Goleta.

AP-85 Other Actions - 91.420, 91.220(k)

Introduction

The greatest obstacle to meeting any underserved need is the lack of sufficient funding, including:

- Limited availability of funding from both federal, state, and other sources;
- High cost of housing and provisions in the area, which increases the difficulty of meeting affordable housing needs; and
- Reduced or frozen funding from the State, including the loss of Redevelopment Funds and other sources due to inadequate State revenue

There is an underserved need for public services across most categories. This includes the needs of the elderly and frail seniors, at-risk youth, working parents, persons with HIV/AIDS and their families, the disabled, individuals with drug, alcohol and chronic illnesses, and persons with other conditions affecting their ability to function independently and productively. There is also a need for general services for low-income residents such as health care, food and clothing, educational programs, and case management.

Actions planned to address obstacles to meeting underserved needs

The City of Goleta will provide the maximum amount of CDBG funding allowed towards public services (15% of its allocation) which will help address the needs of youth, homeless and low-income people in general, including family resources for low-income parents, as well as case management support to assist the homeless and prevent homelessness.

There is a need within the City to address existing barriers to low-income families and those persons with disabilities. In PY 2024, the City will work to address some of those needs. The City will allocate approximately 65% of its CDBG funding for critical improvements at the Goleta Community Center in Old Town Goleta. The Goleta Community Center also houses the City's only Senior Center. These improvements include rectifying structural issues in classrooms and other areas of the Community Center that are in need of critical improvements. The Goleta Community Center is the only community center serving this high-density area of low-to moderate-income residents. This CDBG funding may also provide leveraging opportunities to add additional enhancements and upgrades to the Center.

To address other underserved needs, in PY 2024 City staff will also focus on the following programmatic and administrative areas:

- Staff will continue to research availability of future funding resources and use proactive approaches toward future applications for potential leverage funds; this will assist the City to strategically place future activities in line to address the above obstacles.
- CDBG and other funds will be used as leverage for the City administered programs and support

services that serve the needs of low- to moderate-income citizens.

Actions planned to foster and maintain affordable housing

The high cost of housing in the area significantly increases the difficulty of meeting affordable housing needs and the City has limited resources with which to develop affordable units on its own. Staff will continue to research and explore public/private partnerships in the construction and development of affordable housing. The City will continue to look for opportunities to leverage its HOME funds and affordable housing in-lieu fees to assist private developers in the construction of new affordable housing.

Actions planned to reduce lead-based paint hazards

The Santa Barbara County, Public Health Department, works in coordination with the California Department of Health Services, Childhood Lead Poisoning Branch for program planning, outreach, case management, investigation, and surveillance of lead-poisoned children.

A Public Health Nurse (PHN) identifies and case-manages lead-burdened children throughout the county and provides outreach and education to the community. A multi-departmental Childhood Lead Poisoning Prevention (CLPP) Team, which includes representatives from the Women, Infants, and Children (WIC) program, California Children Services (CCS), Environmental Health Services, Community Health Division Program Administration, and the County Fire Department-HAZMAT, meets quarterly to plan outreach activities, prepare educational materials, resolve current issues, and discuss responsibilities in investigating lead poisoning cases. This program has increased lead screening done on children at risk for lead poisoning.

The City of Goleta will also make copies of the most recent EPA publication, Renovate Right: Important Lead Hazard Information for Families, Child Care Providers and Schools available to the public at City Hall. In addition, the City's Planning and Environmental Review Department will provide the most recent EPA educational brochures on lead poisoning to anyone seeking a permit or information for renovation of a residence, day care center or school which includes work on a structure older than 1978.

Actions planned to reduce the number of poverty-level families

The City of Goleta supports various public service programs, both with its CDBG funding and its own General Funds, to provide essential services to reduce the number of poverty-level families.

Actions planned to develop institutional structure

One of the institutional gaps identified was that few services are located within the City of Goleta, so residents have to travel to receive services. The City will continue to work with service providers to offer

Annual Action Plan 2024 services in Goleta and will support those programs that do with CDBG and/or General Fund money.

Actions planned to enhance coordination between public and private housing and social service agencies

The City will continue to collaborate with public and private housing and social service agencies to meet the goals and objectives of the Consolidated Plan. This includes attending and coordinating ongoing meetings, special meetings and/or participation on relevant task forces.

Discussion

Among the partners the City works with is the Housing Authority of the County of Santa Barbara. The Housing Authority owns and/or manages 148 units within the Goleta City limits and owns and/or manages over 100 additional rental housing units just outside the City limits that have Goleta addresses. The Housing Authority also provides rental assistance to 252 low-income families within the City as follows: 117 through Section 8 Housing Choice Vouchers; 121 through Section 8 Project-Based Vouchers; 14 through Section 8 Project-Based Rental Assistance.

On January 11, 2022, the County Board of Supervisors approved local capital matching funds in order for the Housing Authority to apply for a \$16 million state Homekey grant to provide permanent supportive housing for persons who are experiencing homelessness or at-risk of homelessness. The funds were used to purchase the Super 8 hotel located at 6021 Hollister Avenue in Goleta. On January 5, 2022, the Goleta City Council approved the use of \$600,000 in City ARPA funds toward the project's local capital match. The 60-unit housing project will be owned and managed by the Housing Authority of the County of Santa Barbara. Goleta-area homeless persons have already been identified as being a good fit for housing in the project and have started to occupy the recently renovated facility. Homekey is a California program to purchase and rehabilitate housing, including hotels, motels, vacant apartment buildings and other properties, and convert them into permanent, long-term housing for people experiencing or at risk of experiencing homelessness.

han llevado su
lucha a los tribunales.

El Centro por los Derechos Constitucionales y el American Immigration Council (AIC) ha presentado una solicitud ante una corte federal en California, Estados Unidos.

Exigen que el Gobierno del presidente Joe Biden detenga la práctica de regresar a solicitantes de asilo que llegan a los puertos fronterizos.

Esta solicitud surge como parte de una demanda más amplia presentada en julio del año pasado por la Alianza Bridge Haitiana.

Los abogados a cargo de la demanda han anunciado la presentación de la solicitud al Tribunal de Distrito Federal del sur de California, en un comunicado.

La política de permitir que los solicitantes de asilo presenten sus casos sin una cita previa ha sido un punto de controversia desde hace tiempo.

Los defensores de los inmigrantes argumentan que esta práctica es esencial para garantizar que aquellos que huyen de situaciones peligrosas tengan acceso rápido y seguro al proceso de asilo.

Por otro lado, críticos de esta política sostienen que puede resultar en una sobrecarga de inmigración y que podría permitir el ingreso de personas que no califican para el asilo legitimo.

La Alianza Bridge Haitiana y Al Otro Lado, junto con los solicitantes individuales de asilo, están en el centro de esta demanda. Cabe mencionar que estas organizaciones han estado en la primera línea de la lucha por los derechos de los inmigrantes

Y han presenciado de primera mano los desafíos y dificultades que enfrentan aquellos que buscan asilo en los Estados Unidos.

Su objetivo es asegurar que la política de asilo sea justa y accesible para todos los que la necesitan, de acuerdo con la Agencia Efe.

La administración de Biden ha enfrentado una serie de desafíos en materia de inmigración desde que asumió el cargo.

Aunque ha prometido adoptar un enfoque más humano y compasivo en comparación con la administración anterior, la política de asilo ha demostrado ser un terreno complicado.

La respuesta de la corte a esta solicitud tendrá implicaciones para la política de asilo y para aquellos que buscan protección en el país.

Cabe recordar que el pasado mes de mayo el Gobierno del presidente Biden estableció nuevas reglas para el proceso de las solicitudes de asilo

Requiriendo que quienes busquen esa protección deben obtener una cita a través de la aplicación de la Oficina de Aduanas y Protección de Fronteras (CBP).

Tanto los solicitantes de asilo como sus defensores han criticado la medida argumentando que la obligatoriedad de obtener una cita "limita en gran medida" las opciones de los solicitantes.

Los demandantes han pedido que fuerce a la Administración de Biden a procesar a todos los solicitantes de asilo "independientemente de si tienen la suerte de obtener una cita en CBP One".

Publican informe que muestra la necesidad de mejor salario para trabajadores agrícolas

a Alianza Campesina de la Costa Central (Alianza Campesina), celebró una conferlencia de prensa para publicar un informe titulado "Cosechando Dignidad: El Caso de un Salario Digno para los Trabajadores Agrícolas", que no sólo arroja luz sobre las realidades que rodean el salario que reciben los trabajadores agrícolas y sus condiciones laborales, pero también subrava la necesidad apremiante de que los trabajadores agrícolas reciban una compensación justa por su arduo trabajo.

El informe revela claramente las disparidades salariales, por ejemplo, en 2023, "el salario promedio por hora de los trabajadores agrícolas en el condado de Santa Bárbara era de sólo \$17.42 o \$36,244 al año".

Esto se compara con los conductores de camiones pesados, que recibieron un salario medio por hora de \$26.76 dólares, lo que se traduce en un salario anual de \$55,672 dólares.

Al mismo tiempo, los trabajadores de la construcción ganaron un salario promedio por hora de \$25.04, lo que resultó en un salario anual de \$52,104, según el Departamento de Desarrollo del Empleo de California.

"En los últimos años el aumento del alquiler ha sido un tema que nos ha afectado a mí y a mi familia. Un meior salario me daría acceso a meiores condiciones de vivienda v también me ayudaría a pagar el alquiler, que sigue aumentando. Un aumento también me daría acceso a comidas más saludables para mi familia y nos avudaría a cosechar los frutos de mi trabajo", señaló Matilde, líder de trabaiadores agrícolas de Alianza Campesina.

La discrepancia salarial entre industrias de mano de obra que comparten altas tasas de lesiones y mortalidad en el lugar de trabajo, apunta a la histórica falta de inclusión de los trabajadores agrícolas en los sindicatos, así como a la segregación racial de la fuerza laboral agrícola.

"Las tasas de mortalidad ocupacional en el trabajo agrícola son consistentemente mucho más altas que en trabajos comparables, con 23.5 lesiones fatales por cada 100,000 trabajadores en 2022 en comparación con 14.6 muertes en la conducción de camiones y 13.0 en la construcción", indicó Erica Díaz-Cervantes, defensora principal de políticas de CAUSE.

La investigación también muestra que una caja típica de fresas cuesta a los consumidores entre \$2 y \$6 dólares en el supermercado, dependiendo de la variación estacional y el estado orgánico, y sólo aproximadamente \$0.28 centavos van a parar a los trabajadores que las cosechan.

"Muchos empleados agrícolas no pueden afrontar el costo básico de necesidades como vivienda adecuada, atención médica, cuidado infantil y alimentos, especialmente con el creciente costo de vida en las ciudades a lo largo de la costa central de California", indicó Arcenio López, Director Ejecutivo de la Organización Proyecto Comunitario Mixteco/Indígena. (MICOP).

Además, el informe defiende que aumentar los salarios es necesario para la sostenibilidad de la industria.

La agroindustria está luchando por atraer trabajadores a medida que la población de trabajadores agrícolas envejece, con mayores oportunidades económicas en México y menores tasas de natalidad que conducen a una disminución de la inmigración, y muchos trabajadores agrícolas de larga data abandonan la industría para ir a otros sectores con salarios más altos y condiciones laborales más seguras.

"Si los principales distribuidores corporativos como Driscoll's, que dominan el mercado de las berries, pagaran un poco más a sus proveedores, los trabajadores agricolas podrían recibir un salario digno con poco impacto en el precio final de los productos frescos para el consumidor", recalcó Hazel Davalos, Codirectora Ejecutiva de la Alianza Uni-
