Please read the following instructions regarding next steps to receive your Electrify Your Fleet Program incentive.

- 1. If a purchase order(s) for the vehicles has not been submitted yet, the Applicant is responsible to 1) submit a purchase order to the electric vehicle manufacturer/dealer identified in the application, and 2) share a copy of that purchase order with 3CE via email to programs@3ce.org.
- 2. When the manufacturer/dealer notifies the Applicant that the vehicles are ready for delivery, the Applicant will share a copy of that notice with 3CE via email to programs@3ce.org.
- **NOTE: At the request of the Applicant and upon notice that the vehicle(s) is/are ready for delivery, 3CE may pay the incentive "direct-to-vendor".
- 3. If, according to the manufacturer, the vehicles will not be delivered by September 30, 2024, Applicant will notify 3CE Staff via email to programs@3ce.org. Extensions may be provided at the sole discretion of 3CE.

- 4. After delivery of the vehicle(s), the Applicant shall provide 3CE Staff with payment information, proof of purchase, and documentation that the vehicles were received. Required documents may include:
 - a. Photo or Copy of Purchase or Lease Agreement/Invoice for each vehicle.
 - b. Photo or Copy of Vehicle Registration for each vehicle. Temporary Registration forms will be accepted.
 - c. Photos of EV(s) at customer site.
- 5. If a direct-to-vendor payment has not already been made, 3CE will issue payment via check to Applicant within 45 days of receiving all documentation that the vehicles have been received or have been made ready for immediate delivery.
- 6. Please note: Electric Vehicles must be domiciled at premises that are enrolled in 3CE electric generation service. Electric Vehicle Supply Equipment (EVSE) should be installed and actively enrolled in 3CE electricity service prior to receipt of 3CE's incentive award.
- 7. 3CE reserves the right to request additional relevant information from the Applicant at any time.
- 8. By accepting 3CE's Program incentive, the Applicant named above releases and discharges 3CE, its members, Directors, officers, employees, agents, or representatives from all claims, demands, and liabilities, including bodily injury claims arising out of or in connection with the Program.
