



**NOTICE OF PUBLIC HEARING
Goleta City Council**

**Goleta General Plan / Coastal Land Use Plan
Case No. 07-200-GPA Housing Element Update (Track 1)**

NOTICE IS HEREBY GIVEN that the Goleta City Council will conduct a public hearing to consider adoption of a State mandated General Plan/Coastal Land Use Plan Housing Element update and related Amendments (Case No. 07-200-GPA) referred to as "Track 1." At this hearing, members of the public will have an opportunity to comment on the content of the proposed amendments to the Housing Element including the adoption of the CEQA findings and acceptance of an EIR Addendum. The date, time, and location of the public hearing is set forth below.

PROJECT LOCATION: The affected area includes all territory located within the boundaries of the City of Goleta, comprising approximately 7.9 square miles or 5,075 acres. The City is situated along the U.S. 101 freeway about 10 miles west of Santa Barbara between the foothills of the Santa Ynez Mountains and the Pacific shoreline. The southerly portion of the City is within the California Coastal Zone.

PROJECT DESCRIPTION: The Goleta General Plan / Coastal Land Use Plan Housing Element contains policies that guide future housing development to meet the needs of all income groups and special needs groups in the City of Goleta. The City refers to the set of proposed amendments to the Housing Element as "Track 1." "Track 1" General Plan Amendments require an Addendum to the General Plan / Coastal Land Use Plan Final EIR (EIR# 05-EIR-01, SCH# 2005031151) adopted in October 2006. The update to the Housing Element is required under State Government Code 65588 and addresses the State allocated Regional Housing Needs Allocation.

HEARING DATE, TIME AND LOCATION: All interested persons are encouraged to attend the public hearing and to present written and/or oral comment on the scope and content of the proposed amendments to the Goleta General Plan / Coastal Land Use Plan.
