

## NOTICE OF PUBLIC HEARING Goleta City Council

## Goleta General Plan / Coastal Land Use Plan Case No. 07-202-GPA (Track 3)

**NOTICE IS HEREBY GIVEN** that the Goleta City Council will conduct a public hearing to consider adoption of proposed General Plan / Coastal Land Use Plan Amendments (Case No. 07-202-GPA) referred to as "Track 3" Substantive Revisions. At this hearing, members of the public will have an opportunity to comment on the content of the proposed amendments to the General Plan including the adoption of the CEQA findings and acceptance of the Final Supplemental EIR. The date, time, and location of the public hearing is set forth below.

**PROJECT LOCATION:** The affected area includes all territory located within the boundaries of the City of Goleta, comprising approximately 7.9 square miles or 5,075 acres. The City is situated along the U.S. 101 freeway about 10 miles west of Santa Barbara between the foothills of the Santa Ynez Mountains and the Pacific shoreline. The southerly portion of the City is within the California Coastal Zone.

**PROJECT DESCRIPTION:** The Goleta General Plan / Coastal Land Use Plan contains policies that guide future development in the City of Goleta. The City is considering amendments (Case No. 07-202-GPA referred to as "Track 3" Substantive Revisions) to the Land Use, Open Space, Conservation, and Transportation Elements of the General Plan Coastal Land Use Plan. "Track 3" General Plan Amendments require a Supplemental EIR and an Addendum, to the General Plan / Coastal Land Use Plan Final EIR (EIR# 05-EIR-01, SCH# 2005031151) adopted in October 2006.

**HEARING DATE, TIME AND LOCATION:** All interested persons are encouraged to attend the public hearing and to present written and/or oral comment on the scope and content of the proposed amendments to the Goleta General Plan / Coastal Land Use Plan.
