Mayor Pro Tempore Onnen reported the Finance Committee met at the Goleta Library with County of Santa Barbara, City of Goleta and City of Santa Barbara staff to discuss revenue enhancement for the library with Supervisor Wolf. Mayor Pro Tempore Onnen also reported the Economic Development & Revitalization Committee met to discuss the Economic Development Strat Plan.

Councilmember Easton reported receiving a letter from Randy Rossness, Goleta Valley Community Center Executive Director, noting that he will be retiring January 31, 2010.

Councilmember Connell reported attending the opening of the Brandon school new auditorium along with Councilmember Bennett, noting that a Board Member expressed interest in the joint City Council/Santa Barbara School District meeting to discuss issues of mutual interest or concern.

D. CITY MANAGER/STAFF REPORT

Dan Singer, City Manager, reported that as of September 1, 2009, the City of Goleta has started the Goleta Prepared Now Campaign, noting this campaign is being funded by a grant received through the Orfalea foundation. Mr. Singer informed the public that the City of Goleta, Red Cross, and Chamber of Commerce will be reaching out to the community with Goleta Prepared Now booths at various locations within the City throughout the month of September. Dan Singer, City Manager, also announced that the Monarch press comes out this week and requested the public contact City Hall if they do not receive a copy in the mail. Mr. Singer reminded the public that City Hall will be closed for Labor Day on Monday, September 7, 2009, and that efforts are underway to schedule a joint City Council/Santa Barbara School District meeting to

discuss issues of mutual interest or concern, date and details are still to be determined.

E. CITY ATTORNEY REPORT

Tim W. Giles, City Attorney, reported that AB 566, legislation addressing mobile home subdivision statute, was prepared for a third reading in the Senate and final adoption last week and has been continuing day to day as the various votes are being marshaled in that effort. Tim W. Giles reported that he authored a letter with the County of Ventura County Counsel and the City Attorney of the City of Carson addressing a number of issues raised by legal counsel for the Mobile Home Park Owners Association. Through these efforts this legislation will work its way through the legislature, onto the Governor's desk and hopefully resolve some of the issues. Tim W. Giles, City Attorney, reported that the one trial court that had ruled in favor of a local agency, which had attempted to apply additional conditions to a mobile home park subdivision in the County of Sonoma, was up on appeal and within the last week the decision came down that the ruling was adverse to the County. This decision makes it unanimous of all court decisions relating to this issue and so the last recourse is the Legislative effort, the City will continue to support the effort to make those modifications as necessary.
