Ex-parte conversations: Councilmember Easton reported seeing the project as a Design Review Board member and Planning Commissioner. Councilmember Easton reported that he recused himself at the last Planning Commission meeting of November 10, 2008. Councilmember Easton stated that he would be able to make an independent judgment on this item today before Council.

Councilmember Bennett reported meeting with the applicant.

Councilmember Connell reported meeting with both the applicant and appellant.

Mayor Pro Tempore Onnen reported meeting with Detlev Peikert.

Cindy Moore, Senior Planner read into the record the following correspondence: correspondence dated May 28, 2009, from Peikert Group Architects; correspondence received June 1, 2009 from Barbara Massey; correspondence received June 1, 2009, from Mark Linehan, Wynmark Company; and correspondence received June 1, 2009, from the Law Office of Barbara Macri-Ortiz. Ms. Moore provided a PowerPoint presentation on the proposed project.

OPENED PUBLIC HEARING AT 8:24 P.M.

APPELANT:

Richard Foster, appellant, spoke to the three requested modifications as listed on staff report; a modification for zero lot line on all attached units, rather than the 10 feet required; a modification from the required parking design to allow vehicles to encroach into the private street when backing out and a modification from the required minimum perimeter landscaping to allow 6'6" rather than the 10 feet required. Mr. Foster expressed concern that if any one of these granted modifications is removed the project design would be

infeasible. Mr. Foster also raised concerns over the patio size that the patios only receive sunlight during the mid-day hours. He stated his appeal is about size, bulk and scale, conforming to the zoning code and complementing and blending in with the community. He also raised concerns that Citrus village, as approved, has not resolved the State Density Bonus and Local Inclusionary requirements, he noted it does not blend in with the neighborhood, and does not accommodate the whole community, nor does it conform to current zoning code. Mr. Foster requested Council uphold his appeal.

APPLICANT:

Detlev Peikert, project Architect, reported the proposed project meets the intent and policies of the General Plan and Housing Element. Mr. Peikert reported the site is zoned appropriately and meets the intent of the zoning ordinance.

Lisa Plowman, Peikert Group Planning Manager, provided a PowerPoint presentation outlining the proposed project history, 12 unit project, Appeal Issues, and State Density Bonus & Inclusionary Housing Policy and is further available for questions.

Barbara Massey, Gary Vandeman, and Karen Lovelace spoke in opposition of the proposed project.

Debbie Cox Bultan, Coastal Housing Coalition; and Ken Knight spoke in support of the proposed project.

APPLICANT REBUTTAL:

Lisa Plowman reported the shadow study represents the darkest day of the year to demonstrate shadows did not occur from 9:00 A.M. to 3:00 P.M. on the adjacent project. Ms. Plowman spoke to the Inclusionary Housing Policy and State Density Bonus Law.

Detlev Peikert reported that the 12 unit version being presented, as compared to the 10 unit version, was unanimously requested by the Planning Commission. Mr. Peikert provided a PowerPoint presentation of the fiscal impacts and benefits of the proposed project. Mr. Peikert requested Council deny the appeal and approve the proposed project.

APPELLANT REBUTTAL:

Richard Foster expressed concerns that if the issue of state subsidy versus local inclusionary rules was significant, it should have been pursued prior to Planning Commission's vote. Mr. Foster also expressed concerns that the

development should fit within the zoning rules and that if the state inclusionary policy needs to be resolved, then the proposed project should return to the Planning Commission. Mr. Foster requested Council support the appeal.
