### E. COUNCIL COMMENTS

Councilmember Aceves reported the Legislative Issues Ad Hoc Committee met January 28, 2010, to review the first draft of the new Legislative platform and will met again on Thursday, February 11, 2010. Councilmember Easton requested that staff bring back to Council options relating to two aspects of the elections process. Councilmember Easton requested options from staff regarding individual contributions that occur in the last two weeks, after the public notice, and how those might be made public; particularly using the electronic media. Secondly, that there is the participation in the electoral process by anonymous organizations that provide funds to a campaign and put information out that could have an impact on elections without any knowledge of who the contributors are. Therefore, requesting staff to bring back to Council options that make this more transparent. Mayor Pro Tempore Connell supported Councilmember Easton's request to staff and suggested contribution reporting documents be made available online

Mayor Onnen reported attending the Goleta Valley Chamber of Commerce Annual Event, the Santa Barbara Chamber of Commerce Annual Dinner, the ribbon cutting ceremony at Sweet Alley in the Camino Real Shopping Center and the Santa Barbara Association Annual Economic Forecast.
