



NOTICE OF PUBLIC HEARING

An Ordinance of the City Council of the City of Goleta, California, regulating the parking of oversized vehicles on public streets within the City limits.

NOTICE IS HEREBY GIVEN that the City Council of the City of Goleta will conduct a public hearing on the date and time set forth below to consider the following:

A proposed ordinance that would generally prohibit oversized vehicles, recreational vehicles, boats, utility trailers, and campers from being parked or left standing upon any public street or highway within city limits at any time. Exceptions would be provided for certain circumstances, such as any vehicle immediately being loaded or unloaded; during such times as emergency repairs are actually being made; for commercial vehicles which are making pickups or deliveries; and for commercial vehicles delivering materials to be used in the repair, alteration, remodeling, or construction of any building or structure within the City for which a building permit has been obtained.

The ordinance would also provide for issuance of a parking permit to allow users of oversized vehicles, recreational vehicles, utility trailers, and campers to park adjacent to their residences or businesses to load and unload, and to allow out-of-town visitors to park in front of the residence which they are visiting for a limited time period. The current proposal would allow for a maximum of 3 consecutive days of on-street parking under these conditions, with no more than 6 days in total allowed in any 60 day period.

All interested citizens, residents, and public or private agencies serving the Goleta community are invited to attend the public hearing.
