### Speakers:

Javier Mariscal, Southern California Edison, Lindsey Taggart, California Energy Commission, Paul Porier (provided a PowerPoint on file), Patricia Bartoliv-Wible, Southern California Edison, and Michael Holiday, American Institute of Architects, spoke in support of the proposed ordinance.

Jerry Bunin, Home Builders Association, spoke in opposition of the proposed ordinance and suggested that any new requirements should be focused on existing homes.

Lindsey Taggart, California Energy Commission, reported that the County Board of Supervisors set a hearing for Tuesday, October 26, 2010, to take another look at the emPowerSBC program which provides financing for energy efficiency measures and spoke to the mechanisms used for lending these funds. Ms. Taggart also spoke to existing building stock energy efficiency and renewable energy upgrade needs.

Jerry Bunin, Home Builders Association, reported that new homes are 50% more energy efficient and will be energy neutral by 2020. Mr. Bunin express concerns that the costs associated with the proposed ordinance would affect the workforce.
