NOTICE IS HEREBY GIVEN that the City of Goleta (City), as Lead Agency under the California Environmental Quality Act (CEQA, Pub. Resources Code, §§ 21000 et seq.), has completed a Draft Environmental Impact Report (City EIR No. 12-EIR-005; Draft EIR), for the Shelby Residential Project (project). A detailed description of the project is provided below. The City invites comments on the adequacy and completeness of the environmental analysis and mitigation measures described in the Draft EIR from April 25, 2014 through June 9, 2014.

A public hearing to take comments on the Draft EIR will be held by the City Environmental Hearing Officer on:

PUBLIC COMMENT PERIOD: The public review period begins on Friday, April 25, 2014 and ends on Monday, June 9, 2014 at 5:00 P.M. Please limit comments to environmental issues, and ensure that comments address the Shelby Residential Project Draft Environmental Impact Report.+Comments relating to the General Plan Amendment proposed by the applicant should be addressed in a separate letter (see Sessociated General Plan Amendment SEIR+ below).

PROJECT DESCRIPTION SUMMARY:

<u>Location</u>: The project site is located at 7400 Cathedral Oaks Road in the City of Goleta, Santa Barbara County (APN 077-530-019). Access to the project is from Cathedral Oaks Road. The 14.38-acre project site is bounded on its north and east by the Glen Annie Golf Course, on its west by El Encanto Creek, and on its south by Cathedral Oaks Road and residential development.

Project Elements: The project includes a subdivision for 64 lots on a 14.38-acre parcel and development of 60 single-family residences. A retention/detention basin is proposed in the southwest corner of the parcel, and a new storm drain would be installed. Runoff would drain into El Encanto Creek, located to the west of the project site. Additional improvements would consist of a community picnic area, an asphalt walking trail, an open turf area, and a childrens tot lot. Infrastructure improvements would include a looped internal road system with one cul-de-sac and two intersections with Cathedral Oaks Road, installation of stormwater curb extensions, installation of landscaping, and installation of a 5-foot-wide interior sidewalk throughout the subdivision. Preliminary raw earthwork volumes are estimated at 27,500 cubic yards of cut and 23,500 cubic yards of fill.

Required Approvals: The project requires City approval of the following applications:

- 1. A vesting tentative map (05-154-VTM), to allow division of the existing 14.38-acre project site parcel (APN 077-530-019) into 64 separate lots, including 60 single family dwellings and four open space areas.
- 2. A rezone (05-154-RZ) to change the zoning designation of the project site from AG-II-10 (Agriculture II, 40-acre minimum parcel size) to 7-R-1 (Single Family Residential, 7,000-square-foot minimum lot size).
- 3. A zone text amendment (05-154-OA) to Goleta Municipal Code (GMC) § 35-219.6 to change the minimum lot width of parcels in the 7-R-1 zone district from 65 feet to 60 feet.
- 4. A Development Plan (05-154-DP) pursuant to GMC § 35-317 to provide project-specific development standards.

ENVIRONMENTAL REVIEW FINDINGS: The Draft EIR identifies and discusses potential impacts, mitigation measures, monitoring requirements, and residual impacts for identified subject areas. Significant and unavoidable project specific and cumulative impacts (Class I) are identified to aesthetic and visual resources (impact on foothill and mountain views from Cathedral Oaks Road, a scenic corridor). Potentially significant, but mitigable, impacts on the environment (Class II) are anticipated in the areas of: aesthetics and visual resources, biological resources, cultural resources, hydrology and water quality, and transportation and traffic. The Draft EIR has been prepared pursuant to all laws, including CEQA. Further, the project site is not listed on any hazardous waste facilities or disposal sites as enumerated under Section 65962.5 of the Government Code.

ASSOCIATED GENERAL PLAN AMENDMENT SEIR: The environmental impacts of the General Plan Amendment requested for the project site are analyzed in a separate Supplemental EIR (%Shelby GPA SEIR+; City EIR No. 12-EIR-003). The Shelby GPA SEIR was prepared at the same time and in coordination with this Draft EIR. The Shelby GPA SEIR analyzes the amendments to the Land Use Plan Map and Open Space Plan Map of the Cityos General Plan/Coastal Land Use Plan. The Shelby GPA would result in no incremental increases to any Class I, II, or III agricultural and farmland impacts identified in the Cityos General Plan/Coastal Land Use Plan Final EIR. If you are commenting on both this Draft EIR and the Draft Shelby GPA SEIR, please provide separate letters that address comments respectively for each EIR.
