Gene Nooney requested that Council study the idea of making any amendments and including an EIR that would go with an amendment.

Deborah Scott spoke in support of staff recommendations. Echoed Mr. Nooney's comments above and also spoke to traffic concerns.

Krista Pleiser, Santa Barbara Association of Realtors spoke in support of the proposed General Plan Amendment. Comment letter on file.

Ann Wisehart spoke in support of staff recommendation, and feels it would be a waste of tax payer money to embark on a study. Also spoke to the water issue on Bishop Ranch, noting that they transferred the water rights to Camino Real Market Place.

Lee Chiacos supports the idea of agriculture land usage, and provided several supporting suggestions for this usage.

Gilda T. Corissa spoke to housing cost issues in the area. Ms. Corissa noted that the issues related to housing costs add to the difficulty in employee retention.

Connie Hannah representing the League of Women Voters, raised issues with the lack of affordable housing, however, spoke in support of staff recommendation.
